MEMORANDUM OF ORAL DECISION DELIVERED BY SYLVIA SUTHERLAND ON MARCH 5, 2013 AND ORDER OF THE BOARD

[1] This was the first pre-hearing conference ("PHC") on the new County of Simcoe Official Plan ("OP") and Growth Plan for the Greater Golden Hoseshoe ("GP") conformity exercise for the County of Simcoe ("County"). Counsel for the County provided the Board with a chronology of events leading up to this hearing, beginning with the initiation in 2005 by the County of the mandatory five-year review of its OP (Exhibit 3).

[2] Roger Beaman, counsel for the County, also explained to the Board that, unlike other GP conformity exercises in the province, the land budget would not be an issue before the Board since it has already been allocated by the Ministry of Energy and Infrastructure ("MEI"). [3] The Board was also advised that the County will seek approval at the next PHC to some portions of its OP. A notice of the County motion will go out in advance.

[4] The primary purpose of this first PHC was to set the stage for at least two future PHCs. To that end, the following were determined and are ordered by the Board:

- 1. That future service is given only to those registered at this first PHC and/or confirmed by the Board. All persons signed in at this PHC will be served, and will be entitled to respond as if they were parties. This list, which includes status being sought, is to be circulated by Friday, March 8, 2013, and completed by March 19, 2013, and filed with the caseworker at the Board.
- 2. That future service is by e-mail unless specifically ordered otherwise by the Board. The County will circulate e-mail lists of appellants, proposed parties and proposed participants.
- 3. Appellants and proposed parties are to provide their draft issues list by e-mail Friday, March 22, 2013, to everyone on the list. The County will compile and circulate them.
- 4. The County motion regarding approval of some portions of the OP will be served by Thursday, March 28, 2013. Reponses to this motion shall be filed by Monday, April 8, 2013.

[5] Two days, **Friday, April 19, 2013, and Monday, April 22, 2013**, have been set aside for a second PHC on this matter. In addition to the motion returnable by the County seeking approval to parts of the OP, this second PHC will include the updating of appellant, party and participant lists, including dealing with any objections to status. It will also include a review of the draft issues lists, the prospects for mediation, the confirmation of further dates, and will deal will any settlements or motions.

[6] A further two days, **Thursday**, **June 20**, **2013**, **and Friday**, **June 21**, **2013**, have been set aside for a third PHC on this matter. At this PHC, the issues lists will be settled as will the procedural order. Any settlements or motions will be dealt with and further dates will be established.

[7] Both PHCs will commence at **10 a.m.** at:

unless otherwise directed by the County which has undertaken to secure the location.
