



# SUBJECT: 2011 INDICES FOR COSTS AND REVENUE TO BE USED IN 2011 FISCAL YEAR BUDGETS FOR MIXED NON-PROFIT PROJECTS (PROJECTS THAT HAVE A COMBINATION OF MARKET AND RGI TENANTS)

## BACKGROUND

The 2011 Index Table presents a combination of indices for costs and revenues for mixed non-profit projects.

As revenue items and cost items for mixed non-profit projects were indexed in 2010, the standard single-year index is required for 2011. The indices for the mixed non-profit revenues and cost items are listed below.

## **PROCEDURE**

The applicable index, from the attached 2011 list, is used to determine the 2011 Benchmark Operating Costs and Benchmark Revenues. When used in the budget, the indices are expressed as 1 plus a decimal number (e.g. 2.6% would be expressed as 1.026).

The 2011 Benchmark Cost index is then multiplied by the 2010 Benchmark Operating Costs to determine the 2011 Benchmark Operating Costs. The 2011 Benchmark Revenue index is then multiplied by 2010 Benchmark Revenues to determine the 2011 Benchmark Revenue.
