## SUBJECT: 2010 INDICIES FOR COSTS AND REVENUE TO BE USED IN 2010 FISCAL YEAR BUDGETS FOR MIXED NON-PROFIT PROJECTS (PROJECTS THAT HAVE A COMBINATION OF MARKET AND RGI TENANTS)

## BACKGROUND

The 2010 Index Table presents a combination of indices for costs and revenues for mixed non-profit projects.

As revenue items and cost items for mixed non-profit projects were indexed in 2009, the standard single-year index is required for 2010. The indices for the mixed non-profit revenues and cost items are listed below.

## **PROCEDURE**

The applicable index, from the attached 2010 list, is used to determine the 2010 Benchmark Operating Costs and Benchmark Revenues. When used in the budget, the indices are expressed as 1 plus a decimal number (e.g. 2.6% would be expressed as 1.026).

The 2010 Benchmark Cost index is then multiplied by the 2009 Benchmark Operating Costs to determine the 2010 Benchmark Operating Costs. The 2010 Benchmark Revenue index is then multiplied by 2009 Benchmark Revenues to determine the 2010 Benchmark Revenue.
