


Figure 2: Current housing stock of the Township.




Figure 1: Settlement areas in the Township of Severn.

As per the County's Residential Land Budget 2019 the Township has a demand for approximately 600 units to accommodate the 2031 forecasted population. This would require the Township to add about 50 new units/year to meet this forecast. The Township is currently building out at about 160% of that rate (Table 2)

By dividing the Rural Unit Supply figure of 200 from the 2019 Land Budget by the average uptake of Rural lots (see Table 2), the Township has an approximate 5.5 year supply of Rural units.
