I, KATHY SUGGITT, MCIP, RPP, of the City of Barrie, in the Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:

- 1. I am the Manager of Policy Planning in the Planning Department at the County of Simcoe (the "County"). As such, I have knowledge of the matters deposed to herein.
- 2. I am a Full Member of the Canadian Institute of Planners and a Registered Professional Planner in the Province of Ontario. I have 24 years of experience in private and public sector planning. A copy of my Curriculum Vitae has previously been filed in these proceedings as attachment A to Motion Record Exhibit 7.
- 3. I have been directly involved in matters respecting the County's updated Official Plan at all stages of the process since August 2008 leading to its adoption by the County on November 25, 2008 through to the endorsement of the proposed modified Plan by County Council on January 22, 2013 and to the present including OMB proceedings to date.
 - 4. In an oral decision on October 24, 2014 the Board approved the Growth Management and Settlement designation policies of the County Official Plan with a few parties having reserved their rights to request additional policy language/clarification on certain policies.
 - 5. The Board also previously approved Table 5.1 of the County Official Plan which is a listing of all recognized Settlement Areas, with the exception of Tioga remaining under appeal.
 - 6. Map Schedule 5.1 Land Use Designations, dated December 2012 Illustrates the Settlement Area Boundaries and Built Boundaries where applicable. Since the start

of the hearing on the County Official Plan, a few portions of the Schedule have been approved for certain Settlement Areas as Issues have been resolved; namely Midland, Penetanguishene, Fennell's Corners, Churchill and Cralghurst.

- 7. The County seeks approval of Map Schedule 5.1 with respect to all Settlement Area Boundaries and Built Boundaries, where applicable, subject to two exceptions; 1) those settlement areas that were previously approved and 2) those that are being withheld by agreement.
- 8. Attached as Exhibit "A" is a copy of Table 5.1 from the Official Plan which is the list of recognized Settlement Areas. Those Settlement Area names with square [] brackets around them were previously approved. Those Settlement Areas with a strikethrough are the ones being withheld by agreement. Approval is sought for all others in the list as they are shown on Schedule 5.1.
- 9. The approval of the Settlement Area Boundaries and Built Boundaries, where appropriate, as illustrated on Map Schedule 5.1 provides the land use designation identification to the policies that were approved in Phase 2a. Furthermore, the approval of the Settlement Area Boundaries and Built Boundaries, where appropriate, will allow the local municipalities to begin implementation and local official plan conformity work.
- 10. It is my opinion that the approval of the Settlement Area Boundaries and Bullt Boundaries, where appropriate, as illustrated on Schedule 5.1 according to the listing in Table 5.1 with the exceptions noted, brings the mapping into conformity with the Official Plan and the Growth Plan policies and is consistent with the Provincial Policy Statement, 2014 and represents good planning.
