7.3 ABORIGINAL ENGAGEMENT

7.3.1 DETERMINING INTERESTED ABORIGINAL COMMUNITIES

On 10 August 2016, Michael Henry of AMICK Consultants Limited was advised by Tammi Taylor of Burl's Creek Event Grounds that the Huron-Wendat had expressed an interest in the project and would like to be involved. Independently, Michael Henry had contacted the Chippewas of Rama First Nation to determine if they also had an interest in this project. On 15 August 2016 Karry Sandy McKenzie, representing the Williams Treaty First Nations, contacted Michael Henry directly to advise him that the entire group of First Nations within the Williams Treaty was interested in this project and that contact to each one and all of these nations could be undertaken through her. The Williams Treaty First Nations include: the Beausoleil First Nation; Georgina Island (Chippewas) First Nation; Rama (Chippewas of Mnjikaning) First Nation; Curve Lake First Nation; First Nation Alderville; Hiawatha (Mississaugas of Rice Lake) First Nation; and Scugog (Mississaugas of Scugog Island) First Nation.

7.3.2 NOTIFICATION & DIRECT CONTACT

Initial notification emails were sent to the appropriate contacts at the Aboriginal communities by Mr. Michael Henry, Partner of AMICK Consultants Limited. Interested First Nations were advised that we intended to complete the recommended Stage 2 Property Assessment and that AMICK Consultants Limited welcomed the participation of interested First Nations communities. These First Nations were also asked to advise AMICK Consultants Limited if they were aware of other communities or organizations representing First Nations who may have an interest in this project.

Email correspondence between Michael Henry of AMICK Consultants and the Huron-Wendat First Nation and the Williams Treaty First Nations are included within Section 7.3.5 below.

7.3.4 RESULTS OF THE ENGAGEMENT PROGRAM

The Stage 2 Property Assessment of the lands within the proposed Temporary Use By-law application that were recommended for Stage 2 Property Assessment based on the Stage 1 Archaeological Background Study, with the exception of the above-noted 3.22 acre parcel that has been removed from the Temporary Use By-law lands, was conducted over the course of 23-26, 30 August, 19-23 & 26 September, 2016 consisting of high-intensity test pit survey at an interval of five metres between individual test pits and high intensity pedestrian survey at an interval of five metres between individual transects. Representatives from the Huron-Wendat First Nation and the Williams Treaty First Nations participated in the conduct of the Stage 2 Property Assessment whenever possible for their respective monitors to attend (Ben Cousineau of Rama First Nation/Williams Treaty First Nations, 24-25 August 2016; Alvin Irons of Curve Lake First Nation/Williams Treaty First Nations, 23-25 August 2016; [Élie Laîné](#) of the Huron -

Wendat First Nation, 19-21 September 2016; and Akian Siuoi of the Huron-Wendat First Nation, 24-25 August 2016.

A preliminary draft and a final draft of this report have been provided to the Huron-Wendat First Nation and to the Williams Treaty First Nations for their review and input. As of the date of submission (13 October 2016), no comments or concerns have been received from the Williams Treaty First Nations regarding the fieldwork, report content, or the conclusions and recommendations for the Stage 2 Property Assessment of the lands within the Temporary Use By-law Application. On 13 October, Maxime Picard Coordinator of Projects in Ontario representing the Huron-Wendat First Nation sent an email to Michael Henry of AMICK Consultants Limited stating, “*Everything seems fine on our side.*”
2016.

The peer review of the original final report received 14 December 2016 resulted in the revelation that a small 3.22 acre parcel had been overlooked in the Stage 2 Property Assessment. An email was sent on 5 January 2017 to the participating First Nations to advise them of this oversight and to also inform them that AMICK Consultants Limited would be undertaking to complete the assessment of this parcel as soon as practical.
