### June 15<sup>th</sup>, 2021 – National Session to share ideas from local micro-labs and confirm prototyping approach

Shared ideas and confirmed prototyping approach

Key Opportunities Identified:

- 1. Conceptualizing housing data via the lens of a measurement framework: assessing current and potential indicators.
- 2. Filling data gaps: Five specific opportunities.
- 3. Developing data access and visualization tools to meet a spectrum of local data analysis capacity.
- 4. Reaching more local decision-makers.
- 5. Data advocacy: sustained engagement of Statistics Canada and CMHC.
- 6. Offering time-tested data-related tools to CDP members.
- 7. Funding the resulting roadmap: building on existing revenue streams and exploring new ones.



### **Updating EDI Boundaries**

### Background


- Early Development Instrument
  - Questionnaire answered by Kindergarten teachers
  - measures children's ability to meet age-appropriate developmental expectations in five general domains
  - Used for planning and service delivery
- Groupings of Dissemination Areas (Das)
- Created by the Best Start Committee members
- Last updated using the 2011Census geographies

### Current Status

- 2011 DAs were compared with 2016 DAs
- A few areas where there were bigger changes in South Simcoe
- Decided to wait for the release of Census 2021 geographies before updating the boundaries

 FSA's can be purchased as custom geos

- Note: StatCan Census FSA boundaries are approximations of the Canada Post FSAs.
- Users have reported postal codes coordinates (using the PCCF file) outside the borders of the FSAs that they are supposed to be in (and thus, in the "wrong" FSA). The response we received from StatCan is that there isn't much that can be done about this issue.

- 2021 geographic information will be released November 17, 2021
  - If shapefiles won't change regardless of any new DAs or CTs in their catchment, then they should be submitted
  - If catchment areas are made up of DAs or CTs, then they can be submitted and always send a revision to StatCan afterwards.
- Custom geo tables will be released as they are available which could make it harder to find the right file but will get the data to us quicker




