- Leads meeting in May



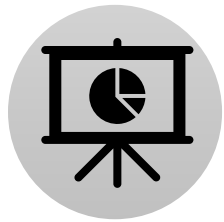
Data Purchase and Access Working Group Meetings

- Visible minority population (broken out by category, including non-visible minority and total visible minority)
- Indigenous identity population [Indigenous identity, Single Indigenous responses, First Nations (North American Indian), Métis, Inuk (Inuit), non-Indigenous identity]

- **Core Housing Need table:** Demographic Status of Household (17), Age of the primary household maintainer (6), Age of the primary household maintainer (6), Household type (7), CMHC housing standards (14), Household data (5), Tenure (3) - [similar to this 2016 table, but with an expanded demographic dimension](#)
- **Educational attainment, demographics, income:** Highest certificate, diploma or degree (16), Age (12), Gender (3), Selected demographic characteristics (28), Income in 2020 (36) - [similar to this 2016 table, but with an expanded demographic dimension](#)
- **NEET table:** Age groups (10), Labour Force Status (8), Gender (3), Attendance at school (5), Work activity during the reference year (9), Job permanency (9), Visible minority, Immigrant and Aboriginal identity status (27) - [similar to this 2016 table, but with an expanded demographic dimension](#)
- **CPP-01:** Selected cultural and demographic characteristics (53), Income status in 2020 - CPP (7), Age groups (33), Sex (3) - [similar to this 2016 table](#)

- Children less than 6 years old
- Collected in 2019, 2020, 2022

Survey on Before and After School Care in Canada (SBASCC)

- Children aged 4 to 12 in school
- Collected for the first time in 2022

What type of child care do they use and why?

What are the barriers to accessing child care?

Why do some families not use any child care?

How much does it cost it?

Relevance to the County

- Help inform decision making
- Factors to consider for Canada-wide Early Learning and Child Care (CWELCC) expansion plan
- More opportunities for conducting surveys or community consultations to understand parent's needs

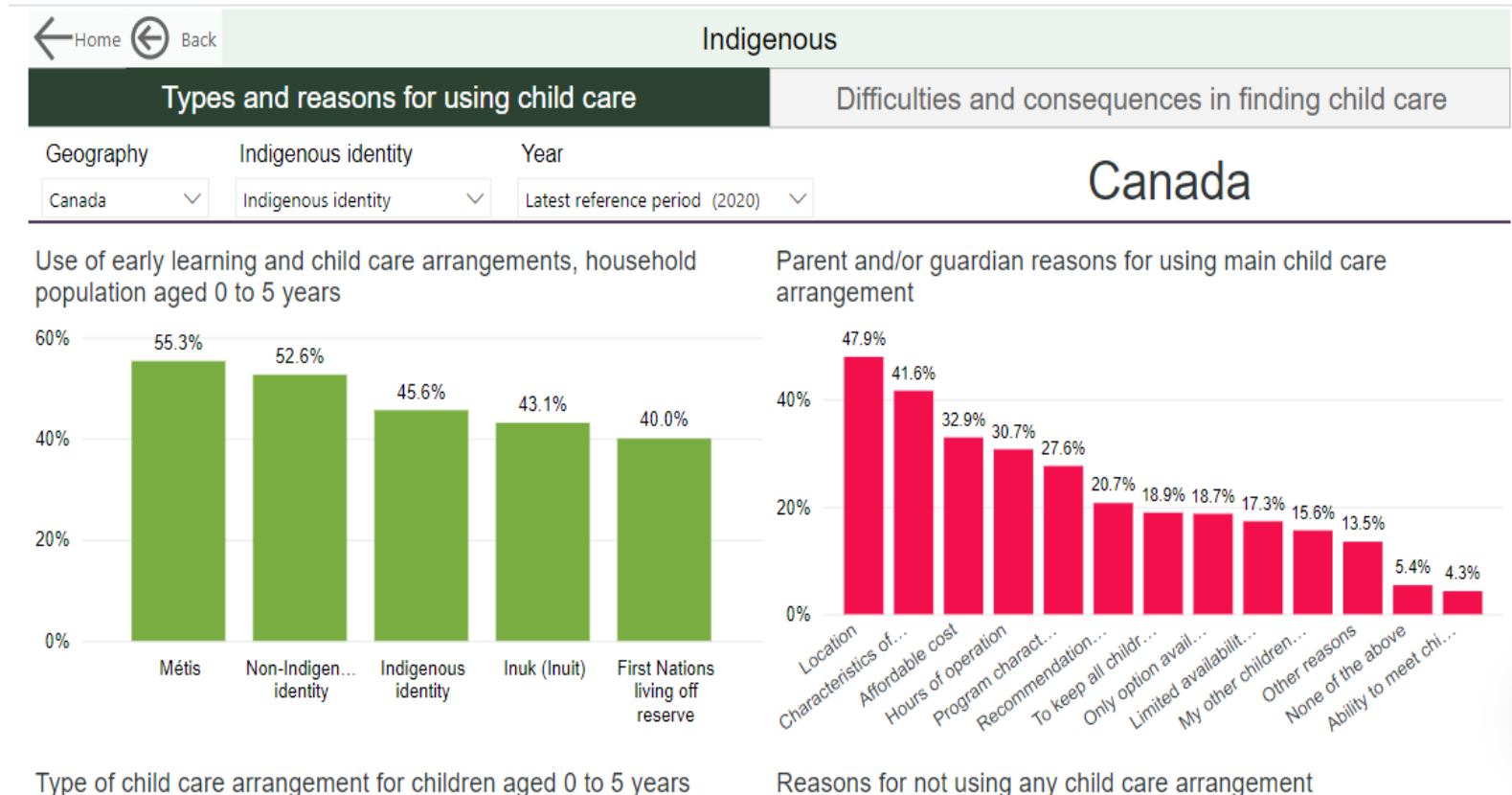

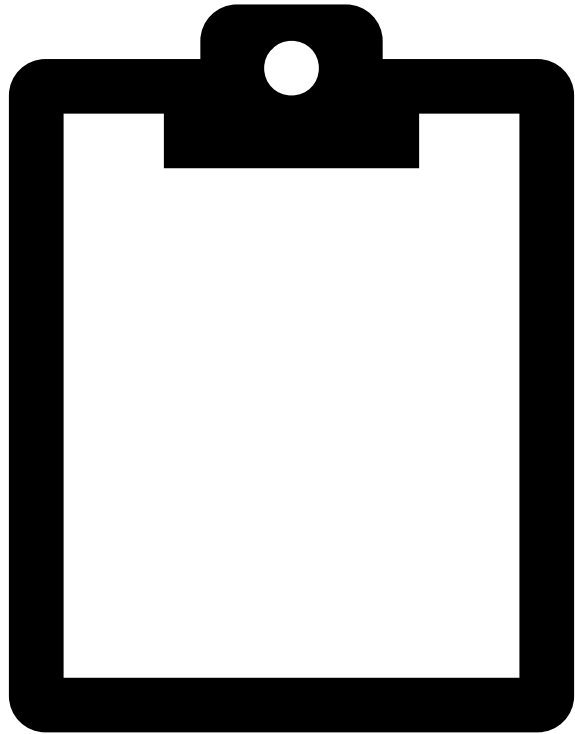
