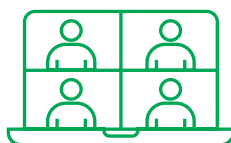

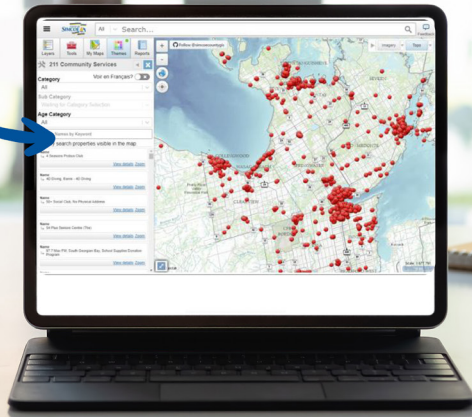

SOLUTIONS LAB

Funded by the National Housing Strategy Solutions Labs, the Community Data Program (CDP) has teamed up with Canada Mortgage and Housing Corporation (CMHC) on a Solutions Lab.

The goal of this Solutions Lab is to help municipalities and community sector organizations find the best way to measure and respond to local housing and housing-related issues through relevant data, visualization, and reporting tools.

The project is expected to span November 2020- March 2022 and occurs in stages. Input from a variety of organizations with diverse data needs will help ensure the outcomes of the solutions lab meet the variety of data needs across Canada.

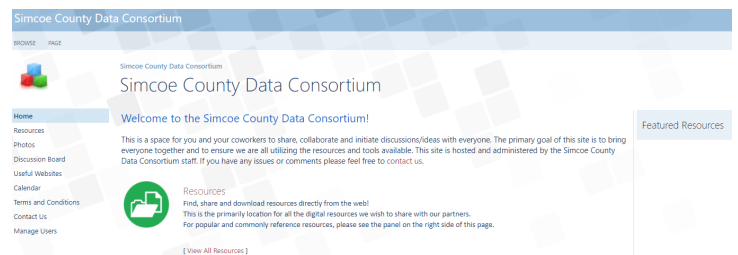
