**b.** Custom Geographies Data Purchase

The group reviewed the geographies for custom 2021 Census data purchasing.

The group talked about how data using Forward Sortation Area's (FSA) isn't as helpful as it includes areas outside of Simcoe County.

**Action:** Victoria to determine if CDP can purchase bankruptcy data at Census Subdivision level in addition to FSA's.

**Action:** Victoria look into Ministry of Children, Community and Social Services (MCCSS) boundaries and we will discuss use/purchase next meeting.

c. Simcoe County 2021 Census data analysis and sharing

The group talked about the value of reports, infographics and dashboards when sharing census data. County of Simcoe does not have the capacity to make dashboards with 2021 Census data available on their website. The Simcoe Muskoka District Health Unit will be updating their HealthSTATS dashboards with 2021 Census data.
