# Agri-Food Asset Mapping in the Greater Golden Horseshoe

Asset mapping is an important tool when building a robust regional database to support growth, decision making, and opportunity for the sector.



What: Seeking business information based on resources that are currently available, such as:

- Business directories
- Information from employment surveys
- Business retention and expansions surveys
- Any data across the whole agri-food value chain, from on farm production to consumption.

**Why:** By participating, Planning and Economic Development staff will have the tools to access accurate and current data that can be used on both local and regional levels.


# **An Open and Transparent Ontario**

As of May 1, 2015, Ontario is the first province to post a draft Open Data Directive for public feedback and is currently in the process of reviewing comments. This directive aims to maximize access to government data by requiring all data to be made public unless it is exempted for privacy, security, or commercially-sensitive reasons. It sets out key principles and requirements for publishing open data and will apply to data created and managed by Ontario ministries and provincial agencies.

To date, Ontario has released nearly 400 open data sets, posted an inventory of government data, launched a voting tool for the public to vote on data sets they'd like released, and released six of the top 25 most-voted on data sets.
