| <u>Arfona Zwiers, Director, Social and Affordable Housing, County of Simcoe</u> – Successful items over 2020 include: Affordable Housing development in Wasaga Beach opened up with 99 units and approx. two thirds targeted to older adults/seniors; Victoria Harbour Affordable Housing build opened up at the end of 2020 with 41 units completely dedicated to seniors and those with disabilities; Recent Council approval for the Orillia development to go forward for 130 units in Orillia including two thirds of those units dedicated to bachelors and one bedrooms primarily to seniors and other vulnerable populations and will open by end of 2024; Approval for a build in Bradford for a build in Bradford with approx 50 units with two thirds targeted to seniors which will open by end of 2023. On another note, we recently have approval for additional funding in our secondary suite program. This may be of interest to seniors where their existing house it too large for them. They will be able to get grant/forgivable loan over a period of years as long as they agree to rent the second suite out at an affordable rent, then at the end of the time period, the money is forgiven. | <u>Åsa Klint Piggott, Manager, Performance, Quality &amp; Development, County of</u><br><u>Simcoe</u> – The Age-Friendly Seniors Housing Grant Program has received<br>approximately 63 applications to date. The Application process closes end<br>of day June 30 <sup>th</sup> . The applications will be evaluated by the end of July and<br>will send out approval letters thereafter. The Municipal Grant is delayed<br>slightly and will be out by end of September this year as we are working on<br>revising the documents. This will also give local municipalities more time to<br>plan. Next week, we'll be starting the outdoor<br>programs with educations, social and recreational activities outdoors at Little<br>Lake Park in Midland. Since the beginning of the pandemic, the<br>Askennonia Senior Centre has distributed 65 free tablets to seniors in North<br>Simcoe through various grants. More grants are available for another 15<br>tablets. Since the beginning of the pandemic, we have offered free virtual<br>programming with no membership fees and outdoor programming last<br>summer. We are involved in the social prescribing through the Older Adults<br>Association of Ontario with cooperation through the Family Health Team in<br>North Simcoe. We have another new program through New Horizons called<br>"Reach Out and Touch Someone" with a community navigator helping to<br>provide assistance virtually to help seniors fill in applications for grants (i.e.,<br>Age-Friendly Housing Grant Program), as well as food security, social<br>programming, etc. This will allow people to age in place in their homes. |        |
