ACCESS TIMELY, EQUITABLE AND TRANSFORMATIVE CARE SERVICES FOR LTC RESIDENTS THROUGH TELEMEDICINE

WHAT IS VIRTUAL CARE?

Virtual care is a health care delivery model, occurring remotely, that enables patients to get equitable access to care sooner and more seamlessly using any form of communication or information technology. This includes all the ways a health care provider can interact with patients, for example annual wellness exams, remote care monitoring, follow-ups after surgery, consultations with specialists, etc.

WHAT IS TELEMEDICINE / VIRTUAL VISIT?

As part of virtual care delivery model, telemedicine, also referred to as a virtual visit, is the treatment of a medical condition without seeing a patient in person. Digital technologies such as eVisit/videoconferencing, phone calls and secure messaging allows patients to connect with health practitioners when inperson visits are not necessary.

The benefits for LTC residents include improved access to specialized care, reduced health inequities and maintaining the patient at the center of care.

WHO CAN ACCESS TELEMEDICINE?

Telemedicine services are available to everyone and covered by OHIP.

WHAT SERVICES CAN BE ACCESSED USING TELEMEDICINE IN LTC?

Services available in LTC include eConsults, Teledermatology, GeriMedRisk, and medical appointments with health professionals across Ontario, such as:

- heart function clinic
- geriatric assessments
- psychiatry
- pain management
- neurology
- dermatology

The Ontario eConsult Program is a telemedicine service accessed via OTNHub that supports physicians and nurse

practitioners in gaining timely access to specialist advice, often eliminating a need for a patient referral, providing high-quality care within the long-term care setting.

HOW CAN I ACCESS TELEMEDICINE SERVICES FOR RESIDENTS?

In LTC, residents, caregivers and health care professionals have access to telemedicine via

the Ontario Telemedicine Network (OTN), which is part of Ontario Health, as well as any additional telemedicine technologies adopted by individual organizations.

To gain access to OTN, an OTNhub account is required. OTNhub.ca establishes an online community that allows individual providers working in healthcare organizations to connect and collaborate with their patients and peers from anywhere in Ontario.
