County Road 93 Phase 4 Reconstruction

The County of Simcoe has awarded the contract to GIP Paving Inc. for the construction of the County Road 93 (CR 93) Reconstruction Phase 4.

The proposed construction limits are on County Road 93 from 300 meters north of Highway 12 to the Balm Beach Road & Yonge Street intersection.

The work includes upgrades to stormwater pipes and structures, driveway and road crossing culvert replacements, curb and gutter replacement, guiderail replacement, and asphalt paving.

GIP Paving Inc. plans to mobilize on **May 1, 2023**. The reconstruction work is scheduled to continue through to **September 30, 2023**.

Lane Restrictions

During road reconstruction operations, traffic speed will be reduced to **40 km/h** through the work zone.

A minimum of two lanes (one each way) will remain open at all times on CR 93 during non-working hours, weekends, and holidays.

Temporary closure of one lane on weekdays (excluding holidays) are anticipated during working hours of 7:00 am to 7:00 pm (12:00 pm on Fridays preceding holiday weekends).

Exposed gravel driving surface may be encountered periodically during construction.

Advanced warning signs will be installed on CR 93 to warn motorists of the traffic disruptions.

Pre-Condition Survey and Well Sampling

GEI Consultants has been retained by the County to carry out pre-condition assessments and well condition survey, sampling and monitoring of homes in close proximity to the construction activities. Please be advised that the pre-condition survey work and well inspection work is scheduled to begin the week of April 10, 2023.

How will I get to My Business?

The Contractor will maintain access to your business. On several occasions, however, direct access to CR 93 may be interrupted.

The contractor will give prior notice of any access restrictions to the businesses.

If you have any special needs for wheelchair access, please advise the R.J. Burnside & Associates Limited Construction Inspector (Neil McCaffrey).

Access for emergency vehicles will be maintained at all times.

Safety

Construction involves the use of heavy equipment and the unavoidable creation of obstacles.

We ask that you caution your children to stay clear of the working area.

We ask that you take extra caution during the construction period to ensure everyone's safety.
