- End of life, palliative care, MAID Michelle Wilson-NLOT
 - Michelle is a Nurse Practitioner team consults with twelve long term care homes and Simcoe Manor is one of them also liaise with Stevenson Memorial Hospital
 - families can access Michelle through staff at Simcoe Manor Michelle's email is mwilson@southlake.ca
 - NLOT supports quality of life for residents in their last 3 months of life continue to support families as they proceed through bereavement
 - support residents who are experiencing life limiting illness, e.g., heart failure/stroke, dementia, cancer
 - as residents are deemed palliative by the PPS (Palliative Performance Scale), scale measures resident's capabilities in 10% increments (of decline) design programs/strategies to support patients living with dignity as they move toward death
 - MAID(Medical Assistance in Dying) is a life/death option for Canadian adults if experiencing loss of abilities for daily living as they proceed through grievous medical conditions, e.g., heart failure/stroke, cancer resident must be cognitively able to provide consent for MAID and resident must be made aware of all other possible care options two independent assessments must be completed upon request, assessments can be completed by doctors or nurse practitioners
 - DNR do not resuscitate
 - ACP advanced care planning
 - GOC goals of care
 - quality of life vs quantity of life
 - use of MAID is currently on hold for mental illnesses, at the federal government level
- Ministry of Health Inspection Report findings Stacey MacKenzie, Director of Nursing Care
 - clothing donations?
 - Ministry of Long Term Care inspection requested revision of concern/complaint forms to include phone contact number for Ministry of Long Term Care all completed forms must be returned to complainant with resolution
 - results/minutes of weekly high risk meetings must be available for all staff members and must be reviewed by all staff regularly

- to determine a resident's ID, re: Resident Safety Policy check photo in Point Click Care, check resident ID bracelet if worn, confirm ID with resident if cognitively aware, confirm ID with family member or another staff member if resident is not cognitively aware
- whereas Ministry inspections look for areas that require improvement, accreditation looks for the good things that are happening in the Homes there are 300 standards to be met Simcoe County's four homes did not meet 2 of those standards result, was an excellent outcome
 - donations Simcoe Manor does not take donations of clothing or assistive devices Rosa keeps minimal up to date assistive device equipment on hand to assist residents temporarily
 - residents should not have personal heating pads should not buy over the counter medications when shopping all medications that are given must be documented
 - mechanical lifts cannot be administered by families/visitors due to legal issues two staff must use lifts for safety
