Terms and Conditions of Forestry Access Permit

1. Access to the County Forest is at the applicant's own risk. The County of Simcoe will not be responsible for any loss or harm suffered by the applicant.
2. The issuance of a permit by the County of Simcoe does not relieve the applicant of the responsibility for complying with all relevant laws, municipal by-laws and the terms and conditions of this Permit.
3. The applicant will indemnify and save harmless the Corporation of the County of Simcoe and its councillors, officers, employees, agents, contractors, and other users from and against all claims, demands, losses, costs, charges, damages, actions or suits whatsoever that the County of Simcoe may suffer or sustain by reason of anything done or omitted to be done by the applicant or the applicant's officers, employees, agents, or subcontractors in accessing the County Forest.
4. A certificate of insurance may be required, at time of application, with the Corporation of the County of Simcoe named as co- insured and held harmless in the event of accidents. The minimum Comprehensive General Insurance requirement is \$2 million per occurrence.

5. The Permit is only valid for the date, time, location, and purpose listed on the application form. All changes and/or deviations from the Permit must be approved by the Forestry Department prior to such activity taking place. A copy of the Permit must be available while accessing the County Forest.
6. The applicant will ensure that the County Forest is restored to a state which, in the reasonable opinion of the County Forester, is as good as or better than its original condition.
